1		DIRECT TESTIMONY OF JAMES BROCK
2	Q.	Please state your name and business address.
3	A.	James Brock, Florida Department of Environmental Protection, 13051 North Telecom
4		Parkway, Tampa, Florida 33637.
5	Q.	Please state a brief description of your educational background and experience.
6	A.	I received a B.S. in Environmental Science from the University of South Florida.
7	Q.	By whom are you presently employed?
8	A.	Currently, I am employed with the Florida Department of Environmental Protection
9		(FDEP)
10	Q.	How long have you been employed with the FDEP and in what capacity?
11	A.	I have been with the Department since August of 2006. I am an Environmental
12		Specialist I in the Drinking Water Section.
13	Q.	What are your general responsibilities at the FDEP?
14	A.	I am responsible for Compliance/Enforcement for East Pasco County. I am
15		responsible for reviewing chemical analysis reports, interpreting Florida
16		Administrative Codes, and answering questions from the public and owner/operators.
17	Q.	Are you familiar with Aqua Utilities Florida, Inc.'s (utility) water system in Pasco
18		County called Zephyr Shores?
19	A.	Yes.
20	Q.	Does the utility have any current construction permits from the FDEP?
21	A.	No. I am not aware of any permits.
22	Q.	Are the utility's treatment facilities and distribution systems sufficient to serve its
23		present customers?
24	A.	No. The system needs a second well in accordance with Rule 62-555.315(2), Florida
25		Administrative Code, and documentation that auxiliary power meets the requirements

- of Rule 62-555.320(14), Florida Administrative Code.
- 2 Q. Does the utility maintain the required 20 psi minimum pressure throughout the
- 3 distribution system?
- 4 A. Yes.
- 5 Q. Does the utility have certified operators as required by Chapter 62-602, Florida
- 6 Administrative Code?
- 7 A. Yes.
- 8 Q. Is the overall maintenance of the treatment plant and distribution facilities satisfactory?
- 9 A. Yes. There are usually some problems from the sanitary survey, but most may be
- 10 small.
- 11 Q. Can you comment further on the corrections you identified above?
- 12 A. Yes, it is not uncommon to find a number of small deficiencies at facilities. In general
- the utility is doing a good job of maintaining these facilities.
- 14 Q. Does the finished water produced by the utility meet the State and Federal maximum
- contaminant levels for primary and secondary water quality standards?
- 16 A. Yes.
- 17 Q. Does this include the lead and copper rule?
- 18 A. Yes.
- 19 | Q. Has the utility's compliance with the lead and copper rule resulted in a lessening of the
- 20 monitoring requirements?
- 21 A. No. I do not believe that to be the case.
- 22 Q. Does the utility monitor for the inorganic contaminants (VOCs) listed in Rule 62-
- 23 | 55.513, Florida Administrative Code, volatile organic contaminants (VOCs) listed in
- Rule 62-55.515, Florida Administrative Code, synthetic organic contaminants (VOCs)
- 25 | listed in Rule 62-55.516, Florida Administrative Code, and all other compounds listed

1		in Rule 62-550, Florida Administrative Code?
2	A.	Yes.
3	Q.	Do recent chemical analyses of raw and finished water, when compared to FDEP
4		regulations, suggest the need for additional treatment?
5	A.	No.
6	Q.	Does the utility maintain the required chlorine residual or its equivalent throughout the
7		distribution system?
8	A.	Yes.
9	Q.	Are the plant and distribution systems in compliance with all the other provisions of
10		Chapter 62, Florida Administrative Code, not previously mentioned?
11	A.	Yes.
12	Q.	Has the utility been the subject of any FDEP enforcement action within the past two
13		years?
14	A.	Yes, a long form consent order is being drafted to address construction without a
15		permit and no second well for Zephyr Shores community system.
16	Q.	Do you have anything further to add?
17	A.	No, I do not.
