AT&T FLORIDA'S REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files its Request for Specified Confidential Classification.

- 1. On July 31, 2007, AT&T Florida filed its Direct Testimony of Larry Bishop and Elizabeth R. A. Shiroishi in the captioned docket. Exhibit Nos. LB-2, LB-3, LB-4 and LB-6 attached to the testimony of Larry Bishop and portions of the testimony of Elizabeth R. A. Shiroishi contain information to be considered confidential business information. A Notice of Intent to Request Specified Confidential Classification was also filed on the same day.
- 2. Pursuant to Rule 25-22.006, AT&T Florida hereby files this Request for Specified Confidential Classification because the above documents contain information considered confidential business information related to the competitive interests of AT&T Florida that is proprietary to AT&T Florida. A more specific description of this information is contained in Attachment A.
- 3. Public disclosure of this information would cause competitive harm to AT&T Florida and provide competitors with an unfair advantage. The information discussed in this Request for Specified Confidential Classification is valuable and AT&T Florida strives to keep it secret. Therefore, such information

should be classified as confidential business information pursuant to Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.
