Recently the Florida Public Service Commission (Commission) received the enclosed customer complaint against UMCC Holdings (UMCC). The complaint was filed by Ms. Leona Middleton. According to Ms. Middleton, UMCC switched her long distance service without authorization. At this time, staff request that you investigate this complaint, contact Ms. Middleton, and provide a written response to her complaint. Your response should verify that Ms. Middleton was contacted and that her complaint has been resolved. You may fax your response to me at (850) 413-6663, or you may respond by email to <u>kcurry@psc.state.fl.us</u>. Also, please provide a letter of authorization (LOA) or a taped third party verification (TPV) wherein the customer authorized UMCC to provide her long distance service.

In addition, it appears that UMCC is providing intrastate interexchange telecommunications (IXC) services in Florida and has not filed a tariff or provided the Commission with the company's current contact information. Rule 25-24.470(1), Registration Required, Florida Administrative Code, states:

No person shall provide intrastate interexchange telephone service without first filing an initial tariff containing the rates, terms, and conditions of service and providing the company's current contact information with the Division of the Commission Clerk and Administrative Services. Please understand that if UMCC fails to respond to the Commission that it may be subject to penalties as prescribed by Section 364.285, Florida Statutes, which states:

The commission shall have the power to impose upon any entity subject to its jurisdiction under this chapter which is found to have refused to comply with or to have willfully violated any lawful rule or order of the commission or any provision of this chapter a penalty for each offense of not more that \$25,000, which penalty shall be fixed, imposed, and collected by the commission; or the commission may, for any such violation, amend, suspend, or revoke any certificate used by it. Each day that such refusal or violation continues constitutes a separate offense.
