## AT&T FLORIDA'S REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files its Request for Specified Confidential Classification.

- 1. On August 6, 2007, AT&T Florida filed its Motion for Summary Final Order. Attached to the Motion as Exhibits are Larry Bishop's Affidavit and Elizabeth Shiroishi's Affidavit. Exhibit Nos. LB-2, LB-3, LB-4 and LB-6 attached to Larry Bishop's Affidavit and portions of Elizabeth R. A. Shiroishi's Affidavit contain information to be considered confidential business information. A Notice of Intent to Request Specified Confidential Classification was also filed on the same day.
- 2. Pursuant to Rule 25-22.006, AT&T Florida hereby files this Request for Specified Confidential Classification because the above documents contain information considered confidential business information related to the competitive interests of AT&T Florida that is proprietary to AT&T Florida. A more specific description of this information is contained in Attachment A.
- 3. Public disclosure of this information would cause competitive harm to AT&T Florida and provide competitors with an unfair advantage. The information discussed in this Request for Specified Confidential Classification is a 17591 AUG 27 b

valuable and AT&T Florida strives to keep it secret. Therefore, such information should be classified as confidential business information pursuant to Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

  Classification contains an explanation of the proprietary information along with a list that identifies the location of the information designated by AT&T Florida as confidential.
