NOTICE OF PROPOSED AGENCY ACTION ORDER IMPOSING PENALTIES AND COLLECTION COSTS, AND REQUIRING PAYMENT OF DELINQUENT REGULATORY ASSESSMENT FEES, OR CANCELING SHARED TENANT SERVICE CERTIFICATE FOR VIOLATION OF RULE 25-4.0161, FLORIDA ADMINISTRATIVE CODE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Pursuant to Rule 25-4.0161(10), Florida Administrative Code, telecommunications companies that fail to pay the Regulatory Assessment Fee, including statutory late payment charges, within 15 days after receiving a delinquent notice, shall be automatically penalized \$500 for a first offense, \$1,000 for a second offense, and \$2,000 for a third offense. The penalty amounts include collection costs. If an entity fails to pay the Regulatory Assessment Fee in full, including statutory late payment charges, along with the penalty amount, that entity's certificate shall be canceled. In this case, Executive Business Centers, Inc. has not paid the fee.

Pursuant to Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee if the certificate was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. Pursuant to Section 350.113(4), Florida Statutes, the Regulatory Assessment Fee return forms, for the period of January 1 through December 31, are mailed to entities at least 45 days prior to the date that payment of the fee is due.

The Division of Administrative Services advised our staff that Executive Business Centers, Inc., Company Code TS183, failed to comply with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, by not paying the fee within 15 days of receipt of the delinquent notice. In addition, Executive Business Centers, Inc. has had two prior dockets for the same rule violation. In Docket No. 001399-TS and Docket No. 031012-TS, the company paid the past due Regulatory Assessment Fees, including statutory late payment charges, and a \$100 settlement in each docket, respectively.

Accordingly, we hereby find it appropriate to cancel Executive Business Centers, Inc.'s Shared Tenant Service (STS) certificate for failure to comply with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, unless the company pays a penalty and cost of collection, together totaling \$2,000, and remits any past due Regulatory Assessment Fees, along with accrued statutory late payment charges, to the Florida Public Service Commission.

If this Order is not protested, Executive Business Centers, Inc.'s STS certificate shall be canceled. If the company pays the penalty and cost of collection, together totaling \$2,000, and remits any past due Regulatory Assessment Fees, along with accrued statutory late payment charges, prior to the expiration of the Proposed Agency Action Order, then Executive Business Centers, Inc.'s STS certificate will remain active. If the company fails to protest the Order or pay the penalty and cost of collection, together totaling \$2,000, and fails to remit any past due Regulatory Assessment Fees, along with accrued statutory late payment charges, prior to the expiration of the Proposed Agency Action Order, then Executive Business Centers, Inc.'s STS certificate should be canceled administratively, and the collection of any Regulatory Assessment Fees should be referred to the Florida Department of Financial Services for further collection efforts. If the company's STS certificate is canceled in accordance with this Commission's Order, Executive Business Centers, Inc. should be required to immediately cease and desist providing shared tenant service in Florida. This docket should be closed administratively either upon receipt of the payment of the penalty and cost of collection, together totaling \$2,000, and any past due Regulatory Assessment Fees, along with accrued statutory late payment charges. or upon cancellation of the company's STS certificate. If Executive Business Centers, Inc.'s STS certificate is canceled in accordance with this Order and it subsequently decides to reapply for a certificate as a shared tenant service company, the company shall be required to first pay the penalty and cost of collection, together totaling \$2,000 and any outstanding fees, including accrued statutory late payment charges. We are vested with jurisdiction over these matters pursuant to Sections 350.113, 364.336, 364.339, and 364.285, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Executive Business Centers, Inc. shall pay a penalty and cost of collection, together totaling \$2,000, and any past due Regulatory Assessment Fees, along with accrued statutory late payment charges, to the Florida Public Service Commission for failure to comply with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, by the end of the protest period. The cost of collection will be subtracted from any monies collected as payments (full or partial) of the penalty and cost of collection, and will be deposited, along with the past due Regulatory Assessment Fees, in the Florida Public Service Regulatory Trust Fund, pursuant to Section 350.113, Florida Statutes. The statutory late payment charges and any portion of the penalty exceeding the cost of collection will be remitted to the Florida Department of Financial Services for deposit in the State of Florida General Revenue Fund, pursuant to Section 364.285(1), Florida Statutes. It is further

ORDERED that should Executive Business Centers, Inc. fail to comply with this Order, the company's STS certificate shall be canceled. It is further

ORDERED that the cancellation of the STS certificate in no way diminishes Executive Business Centers, Inc.'s obligation to pay applicable delinquent Regulatory Assessment Fees, and accrued statutory late payment charges. If Executive Business Centers, Inc. has its certificate canceled, and subsequently decides to reapply for a certificate as a shared tenant service company, the company shall be required to first pay any outstanding penalties and cost of collection and fees, including accrued statutory late payment charges. Any unpaid Regulatory Assessment Fees, and accrued statutory late payment charges, shall be referred to the Florida Department of Financial Services for further collection efforts. It is further

ORDERED that if Executive Business Centers, Inc.'s certificate is cancelled in accordance with this Order, that entity shall immediately cease and desist providing shared tenant service in Florida. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed upon receipt of the imposed penalty and cost of collection, together totaling \$2,000, and Regulatory Assessment Fees, including statutory late payment charges, from Executive Business Centers, Inc. or upon cancellation of the company's STS certificate.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this/these docket(s) before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
