## REQUEST FOR CONFIDENTIAL CLASSIFICATION

Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, hereby requests confidential treatment of certain information contained in a single page of Tampa Electric Company's answers to Third Request for Production of Documents (Nos. 9-14) of the Florida Public Service Commission Staff, and as grounds therefor, says:

- 1. Tampa Electric is this date submitting its answers to Staff's Third Request for Production of Documents (Nos. 9-14) in the above proceeding. A single page of their responsive documents contains confidential information relating to the rates and charges of a consulting firm retained by Tampa Electric to evaluate the company's request for proposals. The consultant has requested that the billing information be held confidential in order to protect the competitive interests of the consulting firm, as relates to future engagements to provide consulting work to other clients.
- 2. Tampa Electric Company's answers to Third Request for Production of Documents Nos. 9-14 of the Commission's Staff includes the single page marked Bates stamp page 60 with the confidential information redacted.
