

Notice is hereby given, pursuant to Rule 25-22.0407, Florida Administrative Code, that West Lakeland Wastewater, Inc. has filed a petition for a wastewater rate increase with the Florida Public Service Commission. The general reason for the requested increase is to allow the Utility to be given an opportunity to recover the cost of customer billing. The City of Lakeland has recently discontinued providing this service to West Lakeland Wastewater, Inc. as part of its electric service billing, and the Utility now must obtain the services of a private billing company.
