AT&T FLORIDA'S AMENDED REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files its *Amended* Request for Specified Confidential Classification ("Request").

1. On August 8, 2007, AT&T Florida filed its Responses to Staff's First Set of Interrogatories and First Request for Production of Documents. AT&T Florida's Responses to Request for Production Nos. 1 and 5 contained information to be considered confidential business information. A Notice of Intent to Request Specified Confidential Classification was also filed that same day.

On August 29, 2007, AT&T Florida filed its Request for Specified
Confidential Classification for AT&T Florida's Responses to Request for
Production Nos. 1 and 5.

Today, AT&T Florida is filing an Amended Request for AT&T
Florida's Responses to Request for Production Item No. 5.

4. Pursuant to Rule 25-22.006, AT&T Florida hereby files this *Amended* Request for Specified Confidential Classification because the above documents contain information considered confidential business information related to the competitive interests of AT&T Florida that is proprietary to AT&T Florida. A more specific description of this information is contained in DOCUMENT NUMBER-DATE Attachment A. 0 8 5 1 4 SEP 18 5

5. Public disclosure of this information would cause competitive harm to AT&T Florida and provide competitors with an unfair advantage. The information discussed in this Request for Specified Confidential Classification is valuable and AT&T Florida strives to keep it secret. Therefore, such information should be classified as confidential business information pursuant to Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

6. Attachment A to AT&T Florida's Request for Confidential Classification contains an explanation of the proprietary information along with a list that identifies the location of the information designated by AT&T Florida as confidential.

7. Attachment B to AT&T Florida's Request for Confidential Classification is redacted copies of the document containing the confidential information.

8. Attachment C to AT&T Florida's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.

9. The original of this Request was filed today with the Office of the Commission Clerk and a copy was served on the Parties.

WHEREFORE, based on the foregoing, AT&T Florida respectfully requests that, pursuant to Section 364.183, Florida Statutes, the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure. 
