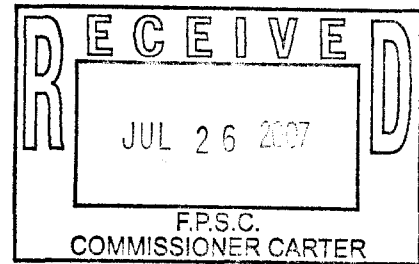

**ITEM 4: DOCKET NO. 070052-GU – PETITION BY PROGRESS ENERGY FLORIDA, INC. TO RECOVER COSTS OF CRYSTAL RIVER UNIT 3 UPRATE THROUGH FUEL CLAUSE.** The Commission will consider a staff recommendation to stay the proceeding pending approval of the uprate project from the Siting Board.
