To all parties:

This morning, TECO filed a notice of withdrawal of its petition for approval of the Polk Unit 6 IGCC to meet its 2013 need. A copy of the notice of withdrawal and an associated press release are attached for your information. The hearing for October 10-11 has been cancelled, all witnesses may be excused, and staff will file notices regarding the cancellation of the hearing.

Staff intends to file a recommendation that the Commission acknowledge TECO's withdrawal of its petition (please refer to Order No. PSC-07-0725-FOF-EU, issued September 5, 2007, in Docket No. 060635-EU, for an example of a similar withdrawal).

At this time, there are a number of pending matters that will need to also be addressed:

(1) FIPUG's petition for intervention. I am requesting that FIPUG confirm its petition may be deemed moot or withdrawn.

(2) SACE's motion to supplement its testimony (and TECO's objection to the motion). I am requesting that SACE confirm its motion may be deemed moot or withdrawn.

(3) Pending requests by TECO's for confidential treatment:

(a) Request for confidential classification and motion for temporary protective order of Document Number 06181-07, filed July 20, 2007.

(b) Request for confidential classification of Document Number 07847-07, filed August 30, 2007.

(c) Request for confidential classification of Document Number 08240-07, filed September 11, 2007.

(d) Request for confidential classification of Document Number 08625-07, filed September 20, 2007.

(e) Notice of intent to seek confidential classification of Document Number 09037-07, filed October 2, 2007.

I am requesting that the documents for which TECO requested confidential treatment be returned to TECO, and that the pending confidentiality requests may be deemed withdrawn.
