This letter is to advise the Commission that AT&T Communications of the Southern States, LLC (AT&T) hereby requests cancellation of its certificate of public convenience and necessity to provide pay telephone service, Certificate No. 8019. The company has ceased its payphone operations in the state of Florida.

Also enclosed please find AT&T's final Regulatory Assessment Fee Filing for 2007 for its PATS certificate as well as a check in the amount \$106.00 as final payment for regulatory assessment fees for 2007. Please note that AT&T considers the information contained in the RAF report to be proprietary and confidential and requests that the report be treated as confidential for as long as the information is held by the Commission.
