Currently, the utility is doing a point repair to the sewer main so that the liner can be installed. The cost of this project has well exceeded the money allocated by FPSC. The estimated cost of repair is \$42,000 and that figure does not include the \$21,904 for the liner. It has further caused delays in the utility being able to start other projects.
