On August 22, 2006, Cypress Lakes Utilities, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water and wastewater service rates, in which it requested interim water and wastewater rate increases of 9.52% and 21.35%, respectively, and final water and wastewater rate increases of 40.99% and 41.73%, respectively. The Commission approved an interim water increase of 9.52% and an interim wastewater rate increase of 21.35% subject to refund with interest by Order No. PSC-06-0661-FOF-WS, dated August 7, 2006.

At the Agenda Conference held on February 13, 2007, the Commission took action on the Utility's application. By Proposed Agency Action Order No. PSC-07-0199-PAA-WS (the "PAA Order"), issued March 5, 2007, the Commission approved a rate increase of 16.81% for its water system and 39.22% for its wastewater system. The Utility implemented these rates in July of 2007. The PAA Order was protested by Cypress Lakes Associates, Ltd. and cross-protested by the Office of Public Counsel. On August 24, 2007, Cypress Lakes Associates and Office of Public Counsel entered into a settlement agreement with the Utility. The settlement agreement did not address or alter the rates approved in the PAA Order. The Commission approved rate increase is therefore 16.81% for the water system and 39.22% for the wastewater system.

The final approval of the rates contained in the attached tables will not cause a change in your current bills because the rates have been in effect since July of 2007.

The Commission also approved new Miscellaneous Service Charges in order to reflect current costs. The Commission approved an increase in water and wastewater miscellaneous charges from \$15 to \$21 for normal hours and from \$15 to \$42 for after hours services. A table of these charges is attached to this notice.
