Re: **Computer Network Technology Corporation** – Surrender of Operating Authority to Provide Telecommunications Services in Florida and Cancel Price List

Dear Ms. Bayo:

Computer Network Technology Corporation (“CNT”) hereby surrenders its operating authority in Florida and cancels its price list on file with the Florida Public Service Commission (“Commission”). CNT emphasizes that it does not currently provide any regulated intrastate services in Florida and that, as a result, the requested relinquishment will not result in the loss of intrastate services by any Florida customers.

In support of this filing, CNT further states as follows:

1. CNT holds authority to provide regulated services in Florida pursuant to authority granted by the Commission (Utility Code TX 748).
2. In connection with that operating authority, CNT maintains a price list (“Price List”) on file with the Commission which was initially filed on October 8, 2003 (Price List No. T031131).
3. CNT is a wholly-owned indirect subsidiary of Brocade Communications Systems, Inc., an entity primarily engaged in the sale of telecommunications equipment and other unregulated services.
4. Although CNT maintains authority to provide regulated intrastate services in Florida, CNT does not currently provide and has not recently provided any regulated intrastate services to customers in Florida.

5. Given that CNT does not provide any intrastate regulated services in Florida, CNT is not currently in receipt of any deposits or prepayments pertaining to intrastate services in Florida.
6. Based upon an internal review of the company's on-going businesses, CNT has determined that it has no plans to initiate regulated operations in Florida. For that reason, CNT no longer wishes to retain its authority to provide service in Florida.
7. In light of the foregoing, CNT respectfully requests that the Commission treat CNT's authority to provide service in Florida as surrendered, treat CNT's Price List as withdrawn, and update the Commission's records to show that CNT is no longer a telecommunications common carrier in Florida.

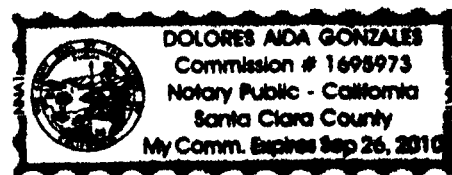
