RE: Docket No. 070620-TP - Request for approval of amendment to interconnection, unbundling, resale, and collocation agreement between BellSouth Telecommunications, Inc. d/b/a AT&T Florida d/b/a AT&T Southeast and Interactive Services Network, Inc. d/b/a ISN Telcom.

By letter received September 25, 2007, BellSouth Telecommunications, Inc. d/b/a AT&T Florida d/b/a AT&T Southeast filed a request for approval of an amendment to the interconnection, unbundling, resale, and collocation agreement with Interactive Services Network, Inc. d/b/a ISN Telcom. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved. The statutory deadline for the Commission to take action on this matter was December 24, 2007.

Staff reviewed the agreement in this Docket on November 27, 2007. The agreement met the criteria outlined in Section 2.07.C.5.d of the Administrative Procedures Manual. Staff notes that AT&T's Accessible Letter CLECSE07-055¹, dated November 16, 2007, which may apply to the underlying, expired agreement, indicates:

Carriers that extended or requested to extend the initial term of an ICA that has already expired pursuant to AT&T's prior policy (i.e., for up to three years from the initial expiration date) may re-submit a request to extend the ICA pursuant to this Accessible Letter. For such carriers, the ICA may be extended under Option 1 for up to three years from the date of carrier's *initial, prior* request, as long as carrier sends the required notice discussed herein by January 15, 2008.

Notwithstanding the above, this amendment has gone into effect by operation of law in accordance with Section 252(e)(4) of the Telecommunications Act of 1996. Accordingly, with this Memorandum, the docket is hereby closed.)
