BEFORE ME, the undersigned authority duly authorized to administer oaths,
personally appeared Alexander Weintraub, who being first duly sworn, on oath deposes
and says that:

1. My name is Alexander Weintraub. I am over the age of 18 years old and I
have been authorized by Progress Energy Florida (hereinafter "PEF" or the "Company")
to give this affidavit in the above-styled proceeding on PEF's behalf and in support of
PEF's Request for Confidential Classification. The facts attested to in my affidavit are

2. I am the Director of PEF's Coal Section in the Regulated Fuels

Department. This section is responsible for coal acquisition for both PEF and Progress
Energy Carolinas ("PEC") systems.

3. As the Director of PEF's Coal Section, I am responsible, along with the

other members of the section, for the procurement of coal for PEC's and PEF's electrical

power generation facilities, and the administration of coal contracts with various suppliers.

4. PEF is seeking confidential classification for certain information provided in response to Staff's First Set of Interrogatories and Staff's First Request for Production of Documents submitted on March 3, 2008. A detailed description of the confidential information at issue is contained in confidential Exhibit A to PEF's Request for Confidential Classification and is outlined in PEF's Justification Matrix that is attached to PEF's Request for Confidential Classification as Exhibit C. PEF is requesting confidential classification of this information because it contains sensitive business information, the disclosure of which would impair the Company's efforts to contract for goods or services on favorable terms.

5. PEF negotiates with potential coal suppliers to obtain competitive contracts for fuel options that provide economic value to PEF and its ratepayers. In order to obtain such contracts, however, PEF must be able to assure coal suppliers that sensitive business information, such as volumes, terms and pricing, will be kept confidential. With respect to the information at issue in this Request, PEF has kept confidential and has not publicly disclosed confidential terms such as volumes, terms, and pricing. Absent such measures, suppliers would run the risk that sensitive business information that they provided in their bids/contracts with PEF would be made available to the public and, as a result, end up in possession of potential competitors. Faced with that risk, persons or companies who otherwise would contract with PEF might decide not to do so if PEF did not keep those terms of their bids/contracts confidential. Without PEF's measures to maintain the confidentiality of sensitive terms in bids/contracts between PEF and coal

suppliers, the Company's efforts to obtain competitive coal supply contracts could be undermined.


6. Additionally, the disclosure of confidential information in PEF's coal supply contracts, could adversely impact PEF's competitive business interests. If such information was disclosed to PEF's competitors and/or other potential suppliers, PEF's efforts to obtain competitive coal supply options that provide economic value to both PEF and its ratepayers could be compromised by PEF's competitors and/or suppliers changing their offers, consumption, or purchasing behavior within the relevant markets.

7. Upon receipt of confidential information from coal suppliers, and with its own confidential information, strict procedures are established and followed to maintain the confidentiality of the terms of the documents and information provided, including restricting access to those persons who need the information to assist the Company, and restricting the number of, and access to the information and contracts. At no time since receiving the contracts and information in question has the Company publicly disclosed that information. The Company has treated and continues to treat the information and contracts at issue as confidential.

8. This concludes my affidavit.


