

**WEST LAKELAND WASTEWATER, INC.
CUSTOMER NOTICE**

Issued March 19, 2008

On July 20, 2007, West Lakeland Wastewater, Inc. filed a petition for a wastewater rate increase with the Florida Public Service Commission to allow the Utility to be given an opportunity to recover the cost of customer billing. The City of Lakeland has recently discontinued providing this service to West Lakeland Wastewater, Inc. as part of its electric service billing, and the Utility now must obtain the services of a private billing company.

On February 13, 2008, the Florida Public Service Commission issued Order No. PSC-08-0083-PAA-SU, which authorized increases in wastewater rates designed to allow West Lakeland the opportunity to recover those increased billing costs. That Order became final on March 6, 2008.
