## Re: Test Year Letter Request for Tierra Verde Utilities, Inc.

Dear Mr. Marcelli:

The Commission received your letter dated April 25, 2008, requesting approval for Tierra Verde Utilities, Inc. (Tierra Verde) to file a rate case using a historical test year ended December 31, 2007, with pro forma plant and operating expense adjustments, for establishing final rates. Docket No. 080248-SU has been assigned to Tierra Verde's application for an increase in rates.

In evaluating the request, we have determined that additional information will be necessary before the Commission can make a determination as to the appropriateness of the requested test year. In accordance with Rule 25-30.430(2)2.(c), Florida Administrative Code, the test year request must include a general statement of all known estimated pro forma adjustments which will be made to the requested test year amounts. While Tierra Verde did include verbiage describing the types of pro forma adjustments that it anticipated including in its request, the filing is deficient as Tierra Verde did not provide an estimate of the pro forma adjustments.

To properly evaluate the merits of Tierra Verde's request, it will need to submit an estimate of the pro forma adjustments associated with plant additions and improvements, as well as, proposed changes to expense. We ask that Tierra Verde submit these estimates by May 30, 2008.
