Dear Mr. Marcelli:

I am writing this letter to give you an update concerning the installation of the proforma plant additions. I will attempt to explain each in the same numerical format as your email.

(12.) We have applied for a permit with the FDEP to go from gas chlorine at the water plant to liquid chlorine.

(13.) This item still needs to be completed. We are waiting to finish the gas chlorine conversion to liquid at the water plant before we finish at the wastewater plant.

(22.) This item still needs to be completed. We are still working with Polk County to see if the EMS station will be connected. We have a meeting scheduled for June 16, 2008.
