

1. On December 4, 2006, the Florida Public Service Commission (the "Commission") issued an Order granting AT&T Florida's Request for Specified Confidential Classification of Document No. 08753-06.
2. The reasons AT&T Florida asserted in support of confidential treatment in its original Requests for Specified Confidential Classification remain. Specifically, there remains a need to protect proprietary business information and competitive interests which is not subject to public disclosure.
3. The information requested remains in the possession of the Commission Staff.
4. For the reasons set forth above, and in AT&T Florida's original Requests for Specified Confidential Classification, AT&T Florida hereby requests that the Commission enter an order extending the period of confidential classification for an


additional 18 months, or for any longer period of time that the documents remain within the possession of Staff.
