

Good morning, Mr. Owen:

I called and left a voice mail message earlier this morning, but also wanted to follow up with an e-mail. The Commission's Fiscal Services section advised me that letters were mailed to you on April 1, 2008, about the returned checks. The letter about the IXC (TK099) had a typo on the amount of the penalty. The letter stated the penalty was \$70 but it actually is \$105. The total amount due for the IXC is \$777, which is comprised of the \$700 fee, \$105 penalty, \$21 interest, \$35 returned check service charge, less the \$84 you sent on April 3rd. The total amount due for the payphone (TH065) is \$121, which is comprised of the \$100 fee, \$15 penalty, \$3 interest, \$15 returned check service charge, less the \$12 you sent on April 3rd.

And, unfortunately, there is even more bad news. On February 21, 2008, delinquent notices were mailed to those companies that had not paid the 2007 Regulatory Assessment Fees, which were due by January 30th. The delinquent notice stated that payment had to be postmarked within 15 days of receipt of the delinquent notice to avoid an automatic fine of \$500 for a first offense, \$1,000 for a second offense, and \$2,000 for a third offense. According to the US Postal Service, the delinquent notices for both certificates were delivered on February 23, 2008. This meant that payment had to be postmarked by March 10th to avoid an automatic fine of \$500 (for each certificate).

I will be opening dockets in a couple of months against those companies not complying with the delinquent notices so the fines are not due yet. An order will be issued and companies will have 21 days to pay the fine and any outstanding fees in order to keep their certificates active.

Dear Mr. Owen:

This concerns your pay telephone certificate. The Regulatory Assessment Fee is applicable if a certificate is active for any day during a calendar year whether a certificate holder had any revenues or ever started operations. The fee must be postmarked by January 30th to avoid late payment charges. Our records show the 2007 fee, including late payment charges, has not been received. The fee is .0020 of a certificate holder's intrastate revenues, or the minimum \$100, whichever is greater.

If you owe the minimum and if payment is postmarked by February 29, the amount due is \$106 (\$100 minimum fee, \$5 penalty, \$1 interest). If you owe the minimum and if payment is postmarked between March 1 and March 30, the amount due is \$112 (\$100 minimum fee, \$10 penalty, \$2 interest). As information, the late payment charges continue to accrue until the fee is paid.

Delinquent notices have now been mailed and if a certificate holder does not comply with the notice within 15 days, certificate holders will automatically be fined \$500 for a first offense, \$1,000 for a second offense, and \$2,000 for a third offense. If the company not comply with the delinquent notice, it would be automatically fined \$500 since this will be the first offense of the Regulatory Assessment Fee rule violation.

If you wish to cancel your pay telephone certificate, please write the Commission a letter requesting cancellation. If you want a voluntary cancellation, please include payment of the 2007 and 2008 Regulatory Assessment Fees, including any applicable late payment charges. If full payment is not included, the Commission would still cancel the certificate, it would just be cancelled on the Commission's own motion and any unpaid fees would be turned over to collections.
