2007 are an overrecovery of \$442,219 for the Marianna Division and an overrecovery of \$949,245 for the Fernandina Beach Division.

5) The estimated true-up amounts for the period January 2007 through December 2007 are an underrecovery of \$629,876 for the Marianna Division and an underrecovery of \$922,558 for the Fernandina Beach Division.

6) As indicated in the prefiled true-up forms, the total true-up amounts to be collected or refunded during the January 2008 through December 2008 period are underrecovery of \$187,657 for the Marianna Division and an overrecovery of \$26,687 for the Fernandina Beach Division.

WHEREFORE, the Company respectfully requests that this Commission enter its order approving the Company's true-up amount for the period January 2007 through December 2007.
