Tampa Electric Company ("Tampa Electric" or the "company") responds as follows to the petition filed in this proceeding on August 26, 2006 on behalf of the Florida Retail Federation ("FRF"), and says:

1. This proceeding was initiated well in advance of FRF's August 26, 2008 petition. This matter was docketed on June 12, 2008, upon Tampa Electric's filing of its test year notification letter pursuant to Rule 25-6.140, Florida Administrative Code. That request was followed on August 11, 2008 with the filing of Tampa Electric's petition for a permanent increase in its base rates and miscellaneous service charges, along with a complete set of minimum filing requirement schedules and the testimony and support exhibits of fourteen company witnesses.

2. While FRF's petition references Rule 25-22.036, Florida Administrative Code ("Initiation of Formal Proceedings"), FRF cannot initiate a proceeding that has already been initiated and its reference to Rule 25-22.036 is misplaced.

3. FRF's petition also, and more appropriately, refers to Rule 25-22.039, Florida Administrative Code ("Intervention"). Under the express terms of this rule FRF, if permitted to intervene in this docket, takes the case as it finds it, which is a rate proceeding initiated pursuant to Section 366.06, Florida Statutes, as reflected in Tampa Electric's petition and in the Order
