The purpose of this prehearing conference will be to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify the exhibits; (5) establish an order of witnesses; and, (6) consider such other matters as may aid in the disposition of the action.

JURISDICTION

Florida Public Service Commission jurisdiction over the rates and charges of investorowned utilities is established by the provisions of Sections 366.04, 366.05, 366.06, and 366.07, Florida Statutes. Jurisdiction to consider recovery of environmental costs is established by the provisions in Section 366.8255, Florida Statutes. Jurisdiction to include costs associated with nuclear power plants through the capacity clause is established by Section 366.93, Florida Statutes.

PRACTICE AND PROCEDURE

All parties will be given an opportunity to be heard. These proceedings will be governed by the provisions of Chapter 120, Florida Statutes, as well as Chapters 25-6, 25-7, 25-22, and 28-106, Florida Administrative Code.
