The raw water is treated with a liquid sodium hypochlorite solution which is injected prior to entry into the 5,000 gallon hydropneumatic tank. The treated water from the tanks is then pumped into the water distribution system which serves the Orangewood Lakes mobile home park (251 mobile homes and a clubhouse), the Orangewood Lakes apartment complex (75 connections), Cypress Knolls (43 homes) and Lakewood Villas (115 homes) service areas. The utility's water service area is built out with no apparent potential for development.

The TMADF for the test year was 43,840 GPD. The wastewater system serves the Orangewood Lakes mobile home park (251 mobile homes and a clubhouse), the Orangewood Lakes apartment complex (75 connections), and Lakewood Villas (115 homes) service areas.

The utility's wastewater service area is built out with no apparent potential for development.


