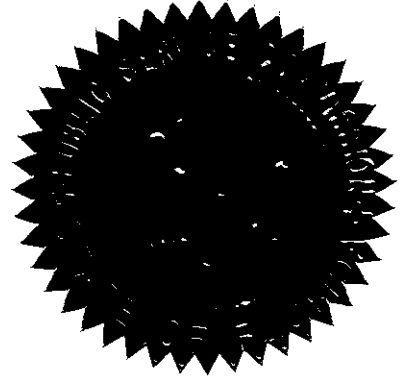

2 **COMMISSIONER ARGENZIANO:** Call our prehearing to
3 order.

4 I hope everyone is rested and doing fine this
5 morning. Good morning.

6 If staff would please read the notice.

7 **MS. HARTMAN:** Pursuant to notice, this time and place
8 has been scheduled for the purpose of conducting a prehearing
9 conference in Docket 080193-EQ. The purpose of the prehearing
10 conference is set forth more fully in the notice.

11 **COMMISSIONER ARGENZIANO:** Let's take appearances.

12 Mr. Anderson.

13 **MR. ANDERSON:** Good morning, Commissioner. Happy New
14 Year.

15 Bryan Anderson appearing for Florida Power and Light
16 Company. My address is 700 Universe Boulevard, Juno Beach,
17 Florida 33410, appearing for Florida Power and Light Company.

18 **COMMISSIONER ARGENZIANO:** Good morning.

19 **MS. KAUFMAN:** Good morning, Commissioner Argenziano.
20 I'm Vicki Gordon Kaufman, and I am with the law firm of Keef,
21 Anchors, Gordon, and Moyle, 118 North Gadsden here in
22 Tallahassee, and I'm appearing on behalf of Wheelabrator
23 Technologies, Inc.

24 **COMMISSIONER ARGENZIANO:** Good morning.

25 Ms. Hartman.

1 **MS. HARTMAN:** Jean Hartman for Commission staff.

2 **MS. HELTON:** And Mary Anne Helton, advisor to the
3 Commission.

4 **COMMISSIONER ARGENZIANO:** Good morning.

5 Are there any preliminary matters?

6 **MS. HARTMAN:** I don't believe there are.

7 **COMMISSIONER ARGENZIANO:** Okay. Anything from the
8 parties?

9 **MS. KAUFMAN:** No, ma'am.

10 **MR. ANDERSON:** No, Commissioner.

11 **COMMISSIONER ARGENZIANO:** We could have some fill-in,
12 we could add a little if we want. No; okay. (Laughter.)

13 Let's move on to the draft prehearing order. I'm
14 working from a copy stamped "draft" that came out yesterday
15 afternoon. Does everybody have the same version?

16 **MS. HARTMAN:** I believe so.

17 **COMMISSIONER ARGENZIANO:** We are all on the same
18 page, okay. I will identify each section sequentially, and I'm
19 going to move through them pretty quickly. Please just holler
20 or raise your hand and let me know if anybody has anything, or
21 corrections or changes that need to be made.

22 Let's move to Section I, Case Background. Any
23 corrections or changes? Hearing none.

24 **MR. ANDERSON:** No.

25 **COMMISSIONER ARGENZIANO:** Okay. Section II, Conduct

1 of Proceedings.

2 **MR. ANDERSON:** No.

3 **MS. KAUFMAN:** No, ma'am.

4 **COMMISSIONER ARGENZIANO:** Section III, Jurisdiction.

5 **MS. KAUFMAN:** No.

6 **MR. ANDERSON:** No.

7 **COMMISSIONER ARGENZIANO:** Moving along. Section IV,
8 Procedure for Handling Confidential Information.

9 **MR. ANDERSON:** No.

10 **COMMISSIONER ARGENZIANO:** Section V, Prefiled
11 Testimony and Exhibits; Witnesses.

12 **MR. ANDERSON:** No.

13 **COMMISSIONER ARGENZIANO:** Section VI, Order of
14 Witnesses.

15 **MR. ANDERSON:** No.

16 **COMMISSIONER ARGENZIANO:** VII, Basic Positions.

17 Okay. How smoothly we're moving along.

18 Issues and positions. Okay.

19 Section IX, exhibit list.

20 **MS. HARTMAN:** Staff would note, for the record, for
21 Section IX, we will prepare a Comprehensive Exhibit List
22 consisting of all the prefiled exhibits for the purpose of
23 numbering and identifying exhibits at hearing, and we'll
24 provide a copy of the exhibit list to parties as soon as
25 possible.

1 **COMMISSIONER ARGENZIANO:** Very good. X, Proposed
2 Stipulations.

3 **MS. HARTMAN:** Staff is not aware of any proposed
4 stipulations.

5 **COMMISSIONER ARGENZIANO:** Pending motions.

6 **MS. HARTMAN:** There is one pending confidentiality
7 request at this time which will be addressed by separate order.

8 **COMMISSIONER ARGENZIANO:** Very good. Pending
9 confidentiality matters. We have just found that there is one
10 pending.

11 Section XIII, Post-hearing Procedures.

12 **MR. ANDERSON:** For the position statement, I often
13 find that fifty words can be very restricting. We try to keep
14 it short, but if we could maybe make that eighty, and we will
15 try to keep it even shorter.

16 **MS. KAUFMAN:** I have no objection.

17 **COMMISSIONER ARGENZIANO:** Staff.

18 **MS. HARTMAN:** That's fine.

19 **COMMISSIONER ARGENZIANO:** Okay. Make it so.

20 Rulings.

21 **MS. HARTMAN:** We would suggest that you make a ruling
22 that opening statements, if any, should not exceed ten minutes.

23 **MS. KAUFMAN:** That should be sufficient.

24 **COMMISSIONER ARGENZIANO:** Very good. Any other
25 matters?

1 **MS. HARTMAN:** We're not aware of any other matters.

2 **COMMISSIONER ARGENZIANO:** Okay, then.

3 It's great to see you all, and we are adjourned.


