Dear Mr. Schumacher:

Pursuant to Order No. PSC-07-0505-SC-WS, issued June 13, 2007, in Docket No. 060253-WS, the Commission granted an increase in rates to Utilities, Inc. of Florida. The Commission found a need to evaluate the effects of the utility's rate proceeding on consumption. To that end, the utility was ordered to file monthly reports of a quarterly basis, detailing the number of customer bills rendered, the number of gallons billed and the total revenues billed with the totals shown separately for the residential and general service classes of service. These reports shall be provided, by customer class and meter size, for a period of two years commencing on the first billing cycle the revised rates go into effect. Attached is the format to use when preparing the quarterly reports.

According to the utility's tariff sheets on file at the Commission, the revised rates for monthly water service were effective July 21, 2007. Therefore, the reports should be provided according to the following schedule:
