

2. On June 29, 2007, the Commission entered an order granting Gulf Power's request. See, PSC-07-0555-CFO-EI.

3. On December 23, 2008, Gulf Power filed a request that the Commission enter an order extending the confidential classification of the confidential documents for an additional 18-month period.

4. On January 19, 2009, Commission Staff returned the confidential documents to Gulf Power, thereby rendering Gulf Power's request for extended confidential classification moot.
