| COMMISSIONER ARGENZIANO: Item 5. Thank you. |
| Let me just make sure I get on the right one, here. |
| Okay. I just wanted to make some comments, because I am |
| finding more and more, as I say, that there is hardly anybody |
| watching, that people are watching. And what I want to you |
| know, because right now we are kind of getting beat up all over |
| the state. I don't know if you guys have gotten the e-mails. |

COMMISSIONER ARGENZIANO: And I will go to the point 1 2 where I need to be. Okay. (2)(a), in a proceeding for an 3 interim increase in rates, the Commission shall, shall 4 authorize within 60 days of filing for such relief the collection of rates sufficient to earn the minimum of range of 5 6 rate of return calculated in accordance with Subparagraph (5)(b)(2). And I just wanted to get that on record, because if 7 somebody is watching, I think they deserve to know what the law 8 says. And I know you all as well as I did raised our hand, the 9 10 right one, and said that we will abide, and that's what we have 11 to do. And we need to have the companies working, being fair

12 to both sides, but I just want those people to know that there 13 14 is a reason for everything, and the statutes dictate what we 15 are going to do, and we shall authorize interim rates. But 16 that it is not a guarantee that that is going to be granted. It is going to be vetted. It is going to go through the 17 18 process that it needs to go through, and if the company has a right to those rate increases, then they shall receive them. 19 20 But I just wanted to get that on record, and I appreciate the time. 21 CHAIRMAN CARTER: Thank you, Commissioner. 22 23 Any further comments? 
