Petition for Arbitration Pursuant to Section 252(b) of the Communications Act of 1934 as Amended, to Establish an Interconnection Agreement with Illinois Bell Telephone Company*, Case No. 08-0545 (Ill. Comm. Comm'n, Feb. 13, 2009). The Illinois PAD is directly relevant to Verizon's Motion for Summary Final Order, filed December 16, 2008, because it addresses the threshold jurisdictional issue of whether Intrado is entitled to seek section 251(c) interconnection for its planned 911 services. The PAD explicitly followed the Florida Commission in finding that Intrado is not entitled to section 251(c) interconnection with incumbent local exchange carriers for the 911 services Intrado seeks to provide.<sup>1</sup>
