
AFFIDAVIT OF PAUL CUTLER

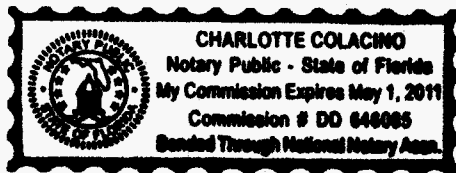
