Dear Homeowner:

Our law firm represents Mobile Manor Water Company, Inc., as general corporate counsel. The water company has previously requested that you complete an application for water service, as required by the Public Service Commission. As of the date of this letter, you have failed and/or refused to complete and return the application.

The Public Service Commission has notified the water company that Tariff Sheet 7.0 requires a signed application prior to the initiation of water service. The application form is approved as Tariff Sheet 20.0. These tariffs have been approved by the Public Service Commission, and all customers and utilities are bound by them. Moreover, a utility may not waive a tariff requirement without approval of the Public Service Commission. (See Florida Administrative Code Rule 2509.001). According to the Public Service Commission, a water service customer must submit a signed application in order to receive, or in this case continue to receive, water service.

Your failure to complete the application not only jeopardizes your right to receive water, but jeopardizes the water company's license under the Public Service Commission. Therefore, demand is hereby made that you complete and return the enclosed application no later than April 15, 2009. If you fail to comply with this demand, the water company will have no other choice but to take whatever legal action is necessary in order to avoid jeopardizing its standing with the Public Service Commission. This action may include, but not be limited to, the discontinuation of water service to your home.
