GT Com asserts that the portions of its Response described below contain proprietary confidential business information regarding the business plans of GT Com. The services addressed in the Response are local services and advanced services. GT Com is currently experiencing competition from other service providers with respect to such services within its service territory.

Pursuant to Section 364.183(1), Florida Statutes, upon the filing of GT Com's claim that such information is proprietary confidential business information, such information shall be kept confidential and shall be exempt from Section 119.07(1), Florida Statutes and Section 24(a), Art. I of the State Constitution. The specific portions of the Response GT Com claims as proprietary confidential business information are as follows:

1. Information regarding the connections that GT Com has equipped as broadband, local exchange telephone service lines and zip code information regarding local voice telephone service, and interconnected VOIP. Disclosure of GT Com's response to these items will provide GT Com's competitors with proprietary confidential business information regarding GT Com's involvement in the market for these services within GT Com's service territory. This type of proprietary confidential business information is not made public under any other circumstances.

A copy of this letter, along with a public copy of GT Com's Response have been hand delivered to Beth Salak, Division of Competitive Markets & Enforcement, concurrent with this filing.
