

Check the Sec of State first to make sure the corporation and the d/b/a is active. If it isn't, they need to do it.

If it is, call the company and tell them to submit a letter to Ann Cole requesting a name change from and to. No cost is involved. It will be docketed and administratively handled in approximately 30 days.

Ask for labels if needed for a tariff or price list be sent to you. Ask them if they have paid their 2008 RAF because the companies must be in good standing with the PSC before any administrative matters can be processed. You will need to print a RAF update to route with the name change memo's if I forgot to tell you that...
