Commissioners, Item 11 is Tampa Electric's proposal to eliminate the customer charge for its general service load management Riders, GSLM-2 and GSLM-3. At the time of the rate case there were no customers taking service on these riders, and TECO proposed no changes to them so they were not addressed in the rate case.

When designing the new Commission-approved IS rate schedule, TECO determined that the customer charges for the underlying rates, IS and GSD, were cost compensatory, and there was no longer a need for a separate customer charge on the riders.

COMMISSIONER ARGENZIANO: Yes, Mr. Chairman.
