

I believe that St. George Island is in danger of being irrevocably changed for the worse if citizens don't take immediate action.

On April 15, Water Management Services, Inc. (WMS), owned by Mr. Gene Brown, filed with the Public Service Commission (PSC) an application for a certificate to build a centralized sewer system on the island. The application states it is only for the commercial district of the island.

However, at a county commission workshop, Brown said he would be willing to extend it into the residential area, if requested. Obviously, there will be capacity built to allow this. It only makes economical sense that all businesses and homes eventually be placed on, or pay access fees for, the centralized system in order to pay for this very expensive endeavor.

This is very serious business, and time is of the essence. Even if you don't live on the island, but do live in Franklin County or own property here, this could affect you. If the island gets centralized sewer, it will open the island up for much greater capacity leading to higher density. This will provide developers with a reason to challenge our height limits, zoning density codes and Comprehensive Plan. With higher density, traffic will increase along with other infrastructure costs. With higher costs, it will require more taxes to pay for the added infrastructure. Who will pay for these higher taxes? The property owners and citizens of Franklin County through higher property taxes and higher millage rates.

In my May 3 letter to the PSC, I urged them not to grant WMS the right to build a centralized sewer system. I told them the recent restaurant septic systems' noncompliance issues are being used as an excuse to rush through a centralized system that will benefit WMS and not the island's property owners. I understand that one of the restaurants has already come into compliance with health department standards and all but one are well on their way to doing so. Therefore, there is no need to build a centralized system for this reason.

It is not in the public's best interest to build a centralized sewer system. There is no documented case I know of where one was built that did not lead to higher density and overdevelopment. I and many other residents and visitors were drawn here because of the uniqueness of low density, low height limits, the natural resources and seafood industry culture.

I believe that two issues are being incorrectly confused in addressing this very important matter: Swimming advisories off the island's beaches and noncompliance of various septic systems in the commercial district and in some of the island's homes.

It is a well-known fact that even if a centralized sewer system were built, it may not eliminate swimming advisories, because no one has yet been able to definitively determine the source of the pollution in the water. Until we know for sure, a centralized sewer may not eliminate the advisories but would only create more problems through increased capacity. This will spur pressure to potentially

overdevelop the island and lead to increased storm water run-off and high costs to property owners for tap fees and to pay for the system.

Overdevelopment also brings other problems and costs, such as the need for adequate parking, increased law enforcement, etc.

By developing codes and enforcing them, existing septic systems can be brought into compliance with little comparative costs and risks. In addition, there are other options available to further reduce ongoing maintenance costs.

I have researched and studied the island's wastewater issues for over five months, and have learned of other technologies available which utilize modular/pod systems that may be a better solution for the island's specific problems. Modular systems would help ensure the island does not experience the pressure to increase development that a centralized system would. It has been said, "Build it and they will come." I am concerned this is exactly what will happen if any entity builds a centralized sewer.

The granting of a certificate to move forward with centralized sewer seems to be on an unusual fast-track under the auspices to help the commercial district. However, any thinking person knows that once a centralized system is built for the business district, it would only be a matter of time that the system would grow to encompass the entire island. This would be the only way that makes economical sense for anyone to embark on this endeavor.

This process needs to slow down so it can proceed in a very thorough and well-thought out manner. It is too premature to grant any entity a certificate for a centralized sewer system. Much study and investigation has to be done to appropriately address the issues. As has already been pointed out, we first have to decide what we are attempting to fix.

If WMS is granted permission to build a centralized sewer system, I believe the island, and entire county, will forever be changed for the worse. It will become just like other overdeveloped barrier islands and coastal communities. Its seafood culture and industry will also be potentially put in jeopardy, destroying many families' livelihoods and way of life.

I am confident county commissioners, residents and health department will take appropriate measures to identify the source of the island's water quality problems, as well as investigate ways to address current septic system non-compliance by some businesses and homes. We are all well aware of the importance to pursue improving the island's wastewater treatment and disposal in whatever way serves the best interests of all its citizens, not just a few.

If you agree with me, please write a letter to the PSC. They need to receive hundreds of letters in protest to be successful in stopping this.

Members of the Public Service Commission:

I am a homeowner and property owner on St. George Island. I have followed the problems we have had with contaminated/polluted beaches and non-compliant septic systems in our central business district, as well as having heard of problems with non-compliant rental properties. I care deeply about the safety and soundness of protecting the unique natural environment that we have on St. George Island and Apalachicola Bay.

My request is that you **decline or defer the application from Water Management Services, Inc.** and Gene Brown for a variance for a certificate to build a centralized wastewater system on St. George Island. I oppose this application because it is to me a classic example of the cart before the horse. I think there needs to be a lot more research before we authorize any applicant. And I do not think it is best practice for the vendor to do the research. The application is vague about the exact nature of the problem and why this firm should be given pre-emptive and apparently exclusive rights. It is my understanding that SGI has had numerous occasions where there are "swimming advisories" issued regarding our beaches. We do not, to my knowledge, know if the runoff from the commercial septic systems on the island is the cause of the pollution. I have reviewed DOH data on testing bay and Gulf sites in Franklin, Bay and other counties. It appears to me that those tests do not identify a single problem source. Further there has been no analysis of the level of compliance of *all* septic systems on the island to see if there is a broader issue than the commercial systems. But this application appears to preclude any other provider that might have a better solution.

While there may have been problems with various commercial businesses and other issues, to my knowledge, no one with relevant knowledge and authority has opined that 1) the problems are caused by non-compliant septic systems in the CBD on the island, 2) that the problems are not also exacerbated by residential septic systems nor 3) that there are no other solutions than that from Gene Brown/WMS. You do not know, based on comprehensive analysis and competitive proposals, that this is the best provider.

Again, I ask that you defer/reject this application. Perhaps in the end it will be the best. But let's not anoint this applicant until appropriate investigation and analysis is done and an open process to qualify the best solution and provider are done. I also note that our county commission has not endorsed this application. Also why is this being considered without local public input? To approve this application at this point eliminates the flexibility to know what the problem is and the best solution therefor. I think it is inappropriate and a violation of your fiduciary duty to the citizens of Franklin County to award a preemptive exclusive certificate of authorization without a fair and balanced process that considers all qualified providers.



There is currently an effort to start the permitting process for the construction of a centralized sewer system on St. George Island, Florida. Since the PSC is a critical cog in the process, I want to state that there are other steps that need to take place first before the PSC hears any petitions to build this centralized system.

We, the island residents and business owners, realize there are problems with the current system of treatment, be it by businesses or residential homes. Identification of the sources of the problems need to be determined by professional experts, who have the experience and technology available to do the testing and specify what exactly the problem sources are and recommend possible solutions, thus negating the necessity for a centralized sewer system.

The major sewer problems seem to occur during the height of our tourist season, when normal occupancy per rental house exceed the original intended house septic system. i.e., too many people for the original system to adequately process the household waste.

I would encourage the PSC to reject any application for a centralized sewer system at the current time.

Do not allow a system which would serve a few, destroy a pristine area and possibly, a fishing industry, should a catastrophic event occur because the system ceased to function.

As residents of St George Island, we would like to express our opposition to the installation of a central wastewater treatment plant on St George. We believe that the presence of such a plant would encourage unrestrained growth on our fragile barrier island that would be counterproductive to the purpose of preventing damage to Apalachicola Bay and the local fishing industry. With a central facility a failure is multiplied by the number of users of the system, but a single-family septic tank will cause a proportionately smaller problem. Instead of a central facility, we recommend that existing regulations regarding aerobic septic systems be more strictly enforced.

Members of the Public Service Commission:

I'm writing to encourage you to deny Water Management Services (WMS), Inc. and Mr. Gene Brown authorization or a certificate to build a centralized sewer system on St.George Island (SGI), FL which was applied for on April 15, 2009.

My wife and I live on St. George Island (SGI) on East Pine Ave.

Although I am not fully informed on your commission's duties, etc, I do understand that you have the authority to grant WMS Inc permission to go forward in planning, designing, and financing a waste water treatment facility for SGI.

If you grant WMS Inc. a certificate to move forward on this health related issue then your commission must believe there is a severe and continual health problem on SGI relating to waste water emanating from homes and commercial institutions.

Professionally I am a biochemist and microbiologist and have been working with scientists from the former Soviet Union in the area of pathogens and severe diseases to animals, plants and humans. I also worked for 25 plus years in biotechnology some of which was in waste water treatment from farm animal production. This work presented me with the challenge of optimizing the treatment of waste water in very small volumes, without odors, and without open lagoon systems. The Japanese have been using systems like these for years because of their lack of open space and high density populations.

If there is a problem on SGI and I have looked at reams of data of water samples collected at 11 St East and West as well as from the Center of the island. There really isn't any indication that the center of the island is causing or is the point source of microbial contamination. I do understand that a restaurant or two have had problems or are still having problems but they have taken steps to maintain a healthy environment.

Therefore, I would like your commission to deny WMS Inc any definite certificate for moving forward until the problem is clearly defined and options to solve occasional non-compliance issues handled using good engineering and biotechnological practices.

Centralized waste water treatment facilities in addition to being expensive, can cause severe problems that will affect the island beyond the present point source from a restaurant or two. Although the centralized system is highly engineered it is the metabolism of a mixed colony of microorganisms that degrades the wastes, reduces the pathogen count, aids in clarification of the water. The bacterial colony can become unbalanced due to storms, electrical outages, chemical make up

of the entering waste water, and a host of other variables. The island due to its elevation, and source of electricity as well as great swings in waste water production due to seasonal use of the island would make it difficult to optimize a waste water treatment facility. When a centralized system becomes imbalanced, non-compliance issues occur on a much larger scale than an individual restaurant's.

If the commission believes that SGI is starting to have problems then it is time to bring the community, and governing bodies together and to get experts in to discuss the problems and potential solutions. To my knowledge this has not occurred.

Once a large engineering effort that is required to build a centralized system occurs; the county, community and citizens have no other choices. Therefore, more information dissemination, and communication needs to be done in the early stages to make all aware of "why and what" is taking place. Presently the feeling we have is, SGI has a waste water problem, there has to be a centralized system built, WMS Inc is the company to save us. Please help clear this feeling by delaying the certificate or permit.

As a resident of St George Island, I request that the Commission reject the above cited application and hold a public hearing to allow citizens of St. George Island to express their opinions regarding a centralized sewer system for the island's "business district".

- 1. The application statement that "the adjacent waters (surf) have been closed numerous times due to high bacterial counts" is completely false. I am unaware that the surf has ever been closed.
- 2. The proposed system will handle 400 ERCs which is twice the size of the business area proposed to be served. Why is excess capacity being built into the plant if it is only to serve the downtown area?
- 3. Input by St. George Island residents was not solicited prior to this application. Only 6 or 8 businesses were contacted.
- 4. At the St. George Island's civic club meeting, Mr. Brown said that all water users would subsidize the sewer system. Why should all water users help pay for the sewer system?
- 5. The application does not specify what type or degree of "advanced wastewater treatment" will be provided. It does not address whether nitrogen and phosphorus nutrients will be removed. The application does not state how or where the sludge will be disposed.
- 6. The application does not address the discharge of 125,000 gallons per day on the sandy soil next to the Apalachicola bay. This treated sewage will have some impact on the bay's vitality.
- 7. Mr. Brown stated at the St. George Island's civic club meeting that the Florida utilities Commission guarantees him 9 to 11% return on his investment.

8, The application does not project sewer impact fees, usage fees, nor the purchase and repair of grinder pumps as required in the application.

- 9. There is no projected construction cost provided.
- 10. No operating costs are projected in the application.
- 11. It is not possible to determine the economic feasibility of the proposed wastewater project based on the information contained in the application. The applicant should present sufficient information to allow an independent determination of the feasibility.
- 12. The private wastewater system proposed is not eligible for state or federal grants or low interest loans, thus increasing user costs. A governmental sewer agency would not charge an additional 9 to 11% profit to its user cost. Consequently a privately owned and financed system will have higher user costs.
- 13. Citizens and property owners on Saint George Island are the people who should decide whether a sewer system is warranted, not an investment group.

My wife and I thank you for the opportunity to offer this input and request you deny the bifurcation request sought by Mr. Brown.





This letter is to object to Water Management Services application to provide waste water treatment on St. George Island by building a central waste water treatment plant.

As residents of St. George Island, our compelling objection is that Mr. Brown's company has proposed a very expensive solution to a problem that has not been properly identified, and it is questionable that the solution he proposes is the best approach environmentally.

Before giving serious consideration to this application, the alleged problem should be proven and detailed with scientific evidence and not anecdotal evidence. Please record my voice in strong opposition to allowing ANY central wastewater treatment plant on St. George Island (SGI). The original 1977 Development of Regional Impact (DRI) outlawed centralized wastewater plants on SGI in order to enforce by law low population density. High population on fragile barrier islands surrounding productive bays such as Apalachicola Bay is the principle source of human contaminants and nutrients that impact water quality. Virtually every scientific study has confirmed that the existence of central wastewater treatment plants leads over time to higher populations, more intense point source groundwater impacts, and ultimately to higher leakage of contaminated groundwater into the Gulf and Bay shorefronts leading to degradation of water quality.

If local septic and aerobic systems are indeed the cause of the local contamination (which is very uncertain), then the proper recourse is strict enforcement by the County of the state laws, regulations and rules governing these systems, not only for the restaurants in the commercial district, but especially those rental homes on the island whose aerobic systems were permitted Certificates of Occupancy by the County at a occupancy count fewer than these homes are advertised for rental and actually sleep when rented.

- Fast-track: Water Management Services Inc.'s request within Franklin County appears to be on a fast-track that has not fully including the views of the residents and absentee property owners on St George Island. Additionally and specifically their application to you puts-off the rates and charges that is naturally a concern to the residents. Competitive solutions and bids would likely provide a broad range of ideas and modern engineering solutions. It would also ensure a

# Time to act against central sewer on island

I believe that St. George Island is in danger of being irrevocably changed for the worse if citizens don't take immediate action.

On April 15, Water
Management Services
Inc. (WMS), owned by
Mr. Gene Brown, filed
with the Public Service
Commission (PSC) an
application for a certificate
to build a centralized
sewer system on the
island. The application
states it is only for the
commercial district of the
island.

However, at a county commission workshop, Brown said he would be willing to extend it into the residential area, if requested. Obviously, there will be capacity built to allow this. It only makes economical sense that all businesses and homes eventually be placed on, or pay access fees for, the centralized system in order to pay for this very expensive endeavor.

This is very serious business, and time is of the essence. Even if you don't live on the island, but do live in Franklin County or own property here, this could affect you. If the island gets centralized sewer, it will open the island up for much greater capacity leading to higher

density. This will provide developers with a reason to challenge our height limits, zoning density codes and Comprehensive Plan. With higher density, traffic will increase along with other

infrastructure costs. With higher costs, it will require more taxes to pay for the added infrastructure. Who will pay for these higher taxes? The property owners and citizens of Franklin County through higher property taxes and higher millage rates.

In my May 3 letter to the PSC, I urged them not to grant WMS the right to build a centralized sewer system. I told them the recent restaurant septic systems' non-compliance issues are being used as an excuse to rush through a centralized system that will benefit WMS and not the island's property owners. I understand that one of the restaurants has already come into compliance with health department standards

and all but one are well on their way to doing so. Therefore, there is no need to build a centralized system for this reason.

It is not in the public's best interest to build a centralized sewer system. There is no documented case I know of where one was built that did not lead to higher density and overdevelopment. I and many other residents and visitors were drawn here because of the uniqueness of low density, low height limits, the natural resources and seafood industry culture.

I believe that two issues

are being incorrectly confused in addressing this very important matter: swimming advisories off the island's beaches and non-compliance of various septic systems in the commercial district and in some of the island's homes

It is a well-known fact that even if a centralized sewer system were built, it might not eliminate swimming advisories, because no one has yet been able to definitively determine the source of the pollution in the water. Until we know for sure, a centralized sewer might not eliminate the advisories but only create more problems through increased capacity. This would spur pressure to potentially overdevelop the island and lead to increased stormwater runoff and high costs to property owners for tap fees and to pay for the system. Overdevelopment also brings other problems and costs, such as the need for adequate parking, increased law enforcement, etc.

By developing codes and enforcing them, existing septic systems can be brought into compliance with little comparative costs and risks. In addition, there are other options available to further reduce ongoing maintenance costs.

I have researched and studied the island's wastewater issues for over five months and have learned of other technologies available which utilize modular/pod systems that might be a better solution for the island's specific problems. Modular systems would help ensure the island does

not experience the pressure to increase development that a centralized system would. It has been said, "Build it, and they will come." I am concerned this is exactly what will happen if any entity builds a centralized sewer.

The granting of a certificate to move forward with centralized sewer seems to be on an unusual fast-track under the auspices to help the commercial district. However, any thinking person knows that once a centralized system is built for the business district, it would only be a matter of time that the system would grow to encompass the entire island. This would be the only way that makes economical sense for anyone to embark on this endeavor.

This process needs
to slow down so it can
proceed in a very thorough
and well-thought out,
manner. It is too premature
to grant any entity a
certificate for a centralized
sewer system. Much study
and investigation has to
be done to appropriately
address the issues. As has
all carly been pointed out,
we first have to decide
what we are attempting
to fix.

If WMS is granted permission to build a centralized sewer system, I believe the island, and entire county, will forever be changed for the worse. It will become just like other overdeveloped barrier islands and coastal communities. Its seafood culture and industry will also be potentially put in jeopardy, destroying many families' livelihoods and way of life.

I am confident county commissioners, residents

and health department will take appropriate measures to identify the source of the island's water quality problems, as Q well as investigate ways to address current septic system non-compliance by some businesses and homes. We are all well aware of the importance of improving the island's wastewater treatment and disposal in whatever way serves the best interests of all its citizens, not just a few.

If you agree with me, please write a letter to the PSC. They need to receive hundreds of letters in protest to be successful in stopping this. Feel free to use all or part of my letter that I summarized above. You can also draft one letter and ask people to sign it as a petition.

Citizens have 30 days from the date of filing to protest the granting of the certificate to WMS. Therefore, the PSC needs to hear from people no later than May 15.

Subject: Request to decline authorization for centralized sewer on Saint George Island

Members of the Public Service Commission,

In the next few weeks, you will be considering a request from Water Management Services, Inc. to build a centralized sewer system for the business district on Saint George Island. I urge you to vote "no" to this request. As a resident of Saint George Island, I do not believe that a centralized sewer system is in the best interest of the residents of Saint George Island.

Water Management Services, Inc. is proposing a centralized sewer system under the guise of addressing an issue with local businesses (i.e., restaurants) creating waste water runoff which is causing bacteria in the Gulf which is subsequently leading to "swimming advisories". The fact is that there has been no in-depth study to determine the source of the bacteria and that it is more likely that Water Management Services is trying to find a new way to make money rather than caring about any problem that exists in the Gulf of Mexico.

As a resident of Saint George Island, I am concerned about how a centralized sewer system will affect my pocketbook and my quality of life. Financially, I believe that the residents of Saint George Island will end up paying some portion of the cost of a centralized sewer system even if it is proposed to be "only for the business district." Furthermore, I believe that the value of my house will eventually fall because a centralized sewer system inevitably leads to higher density and higher density (i.e., increased height limits, zoning changes, traffic, etc.) will be the ruination of this island.

From a quality of life perspective, Saint George Island is currently renowned for its beauty and solitude. As a citizen of Franklin County and a permanent resident of St. George Island, I am requesting that you table or deny the application made by Water Management Services on April 15,2009 for a certificate to build a central sewerage system on St. George Island.

I believe that the application is premature for several reasons which include:

No evidence has been produced to indicate that treating sewage with a central system in the commercial district will solve the problem of "swimming advisories" that are periodically issued throughout the island beach areas. The fact is that many homes are not in compliance with standard waste water treatment practices while only a few restaurants in the middle of the island are found to be non-compliant.

A central sewage treatment plant may not be cost effective if used for only a few businesses. Therefore, the water users on the island might be forced to bear the cost of this expensive type of resolution to the perceived problem.

A central sewerage system will eventually lead to changes allowing higher density on St. George Island. The ecosystem in this area is fragile and deserves the highest level of protection.

Members of the Public Service Commission:

I am a 16-year resident of St. George Island, asking you NOT to grant Water Management Services, Inc. and Mr. Gene Brown authorization or a certificate to build a centralized sewer system on St. George Island (SGI), FL which was applied for on April 15, 2009. I do not desire one, and there is no evidence that one is needed.

As a solution to occasional beach water contamination problems, Mr. Brown, and others, propose a centralized sewer system, particularly for the commercial district in the center of the island, with the potential to eventually expand its scope to the rest of the residential portion of the island. It's also proposed that all of us property owners pay for this system, whether we're yet hooked up to it or not.

I want to see more SCIENTIFIC study of what causes such beach water contamination, and more deliberation on what the solution might be to resolve the problem(s). It might just be as simple as enforcing the current laws regarding septic/aerobic system capacity. I don't want to pay for a system whose cure might kill the patient.

The causes leading to the occasional "closed to swimming" health advisories on Franklin County public beaches have yet to be determined. At Carabelle Beach, the contaminations were suggested to be caused by seagulls and dogs, thus proposing the County Commission post signs on the beach to clean up after dogs, and to avoid feeding seagulls. Other beach closings have been attributed possibly to wild and domestic animal deposits, Red Tide, or decaying aquatic vegetation. Still other causes for "public beach" closings point to too many humans wearing suntan lotion and "doing other things" while swimming in the water. On St. George Island, the speculation is that "closed public beaches" are the result of over-capacity use of under-capacity septic/aerobic systems, particularly in the commercial district, by restaurants.

We don't know if we need, or want such a system. If the residential and commercial districts complied with the laws and ordinances now in place, and the enforcement agencies (such as the Health Department) actually enforced in a timely manner, we would not have to consider the massive expense, noise, odor, catastrophic malfunction tendencies, and the "if you build it, they will come" density problems brought about by the installation of a centralized sewage system and treatment center. Someone needs to examine the malfunction histories of the sewage treatment plants already in place for the motel, and some gated communities on the island; malfunctions have resulted in hundreds of gallons of untreated waste water pouring into the Gulf after a hurricane or severe storm surge.

We don't need or want another so-called "state of the art" centralized system that will be more of a very expensive problem than a solution, especially when we're not sure what the cause of occasional contamination is, or what the solution should be.

Please consider this request to deny the application at this time.



We have been residents of St. George Island for 5 years and strongly object to the above listed Application for Certificate for a Waste Water System contemplated for the center of St. George Island. Nowhere has compelling evidence come forth that this system is in any way needed or justified at this time. The Owner of Water Management Services, Inc. has alleged problems with gulf beach water quality, dangerous levels of e-coli and other vague "violations of public safety issues" that would be mitigated by the creation of the proposed Waste Water Treatment facility.

Unless and until such allegations of public danger be fully documented and corroborated by independent third party testing entities, then no such certificate should be issued. The current use of individual septic systems appears to be operating well within the parameters outlined by county codes and any individual violations can be handled accordingly. To spend millions on a system that is unneeded and for our part unwanted would seem inappropriate, and to burden nonusers with its costs, unconsciousonable.

Noticeably absent in the discussion thus far has been the potential for a failure of a waste water system such as this during and after a major hurricane and the catastrophic impact it could have on Apalachicola Bay. As there can be no guarantee against this possibility, it would seem very rash to take on this type of risk under these circumstances.

It provides income to many Franklin County families and assures the delicate balance of fresh and salt water that produces world class oyster crops year after year. It is inconceivable that the PSC would even contemplate anything that could harm this magnificent water way.

Dear Members of the Florida Public Service Commission:

As residents and long-time property owners on St. George Island, we are interested in the preservation of our community as a viable environment in which residents can live, and visitors can enjoy their vacation time. It is our belief that both the protection of our beaches and bay, as well as the viability of a small business district with restaurants and shops, are important to this community.

The disposal of wastewater on the island has once again become a topic of immediate concern. We have attempted to understand the current issue by attending public forums, including the County Workshop, talking with friends and neighbors, and studying the Application for Original Certificate for a Proposed Wastewater System by Water Management Services, Inc. and associated documents presented to the Florida Public Service Commission.

As a barrier island, St. George Island is an environmentally-sensitive community. We believe that much research and careful thought should be invested in any decision which involves major changes to island infrastructure. Such decisions inevitably will have long-term ramifications on our beaches, wetlands, and Apalachicola Bay.

The Application for Original Certificate for a Proposed Wastewater System by Water Management Services, Inc. does not in our estimation represent the research and careful thought that should go into this decision. The applicant requests a number of variances, which would allow for the evaluation of his request without much of the critical information required in the application. Reasons for the request for these variances appear to be based on time and money.

The applicant seeks to delay provision of information in the following areas:

- Projected cost of the proposed system and related capacity;
- Projected operating expense of the proposed system;
- Projected capital structure, including methods of financing construction and operation of the utility;
- Cost study including customer growth projections;
- Source of funding for the utility.

We fail to understand how the Public Service Commission can decide on the merits of this application without these key pieces of information relating to what the applicant proposes to

build and how he intends to operate and fund the massive cost of such a system. The applicant should be required to invest the time and resources to fully disclose his plans.

We feel that the resolution of issues relating to wastewater disposal in a sensitive island environment warrants much more thorough exploration of the causes of problems and potential solutions than what is exhibited in this application. We request that the variances not be approved and that the application be denied at this time.

Members of the Public Service Commission:

I'm writing to urge you to <u>not</u> grant Water Management Services, Inc. and Mr. Gene Brown authorization or a certificate to build a centralized sewer system on St. George Island (SGI), FL which was applied for on April 15, 2009.

I believe the recent restaurant septic systems' non-compliance issues are being used as an excuse to <u>rush through</u> a centralized system that will only benefit Mr. Brown, not the property owners on SGI. I understand that all but one of the restaurants has already come into compliance with Department of Health standards or are well on their way to doing so. Therefore, <u>there</u> is no need to build a centralized system for this reason.

It is NOT in the public's best interest to build a centralized sewer system. There is no documented case that I know of where one was built that didn't lead to higher density and over-development. SGI and Franklin County are very special places. I and many other residents and visitors were drawn here because of the uniqueness of low density, low height limits, the natural resources and seafood industry culture.

I believe that two issues are being incorrectly confused in addressing this very important matter. The two issues are: 1) swimming advisories off the beaches of St. George Island and 2) non-compliance of various septic systems in the commercial district and in some of the homes on SGI.

- 1) Swimming Advisories: It is a well-known fact that even if a centralized sewer system were built, it may not eliminate the swimming advisories. This is because no one has yet been able to definitively determine the source of the pollution in the water. Until we know for sure, a centralized sewer system may not eliminate the swimming advisories but it would only create more problems through increased capacity. This will spur pressure to potentially over-develop SGI and lead to increased storm water run-off and high costs to property owners for tap fees and to pay for the system. Over-development also brings with it many other problems and costs such as the need for adequate parking, increased law enforcement, etc.
- 2) <u>Non-Compliance of Various Septic Systems</u>: By developing codes and enforcing them, existing septic systems can be brought into compliance with little comparative costs and

risks. In addition, there are other options available to further reduce on-going maintenance costs.

I have been researching and studying St. George Island's wastewater issues for over 5 months. In that time, I've learned that there are other technologies available which utilize modular/pod systems that may be a better solution for SGI's specific problems. Modular systems would help ensure SGI does not experience the pressure to increase development that a centralized system would. It has been said, "Build it and they will come." I am gravely concerned that this is exactly what will happen if any entity builds a centralized sewer system on SGI.

The granting of a certificate to move forward with centralized sewer on SGI seems to be on an unusual fast-track under the auspices to help the commercial district. However, any thinking person knows that once a centralized system is built for the business district, it would only be a matter of time that the system would grow to encompass the entire island. This would be the only way that makes economical sense for anyone to embark on this endeavor. As has already been previously mentioned, there is no logical reason to grant a certificate at this time.

Please deny Water Management Services, Inc. its request. This process needs to slow down so it can proceed in a very thorough and well-thought out manner. It is too premature to grant any entity a certificate for a centralized sewer system on SGI. Much study and investigation has to be done to appropriately address the issues. As has already been pointed out, we first have to decide what we are attempting to fix.

If Water Management Services, Inc. is granted permission to build a centralized sewer system, I believe SGI and Franklin County will forever be changed for the worse. It will become just like other over-developed barrier islands and coastal communities. Its seafood culture and industry will also be potentially put in jeopardy, destroying many families' livelihoods and way of life.

Please be assured that the Franklin County Commissioners, residents and the Department of Health will take appropriate measures to identify the source of SGI's water quality problems, as well as investigate ways to address current septic system non-compliance by some businesses and homes. We are all well aware of the importance to pursue improving SGI's wastewater treatment and disposal in whatever way serves the best interests of <u>all</u> its citizens, not just a few.

Members of the Public Service Commission,

I am urging you to not grant authorization for Water Management Services, Inc. (Gene Brown) to provide centralized sewer service for the central business district on St. George Island, Fl. at this time.

I do not believe that such action will serve the public interest for the following reasons:

- 1. We do not know the source of the pollution we are experiencing. We are located on a barrier island at the mouth of a large river that has a large population up stream. Could that be the problem? Who knows the definitive answer? Could the problem come from animal sources? Over capacity use of septic systems outside of the central business district? We need to factually identify the source and then deal with it correctly and efficiently. Perhaps more performance based enforcement of the existing systems is the answer. We just do not know at this time.
- 2. An <u>independent</u> environmental study needs to be done before any further action takes place on this issue.
- 3. History shows us that a central sewer system inevitably leads to higher density. This will lead more storm water run off problems and adversely affect the water quality, as well as the quality of life for the island residents.
- 4. What is the cost? Will the tap fees and ready to serve fees be forced on everyone? What are the tap fees, ongoing maintenance costs etc.? What if we spend all of this money and still have the problem?

Please slow this process down. We only have one chance to get it right.
