Pursuant to this Amendment (the "Amendment"), BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina and AT&T Tennessee ("AT&T") and Excel Pager, Cellular, and Home Phone, Inc. ("Excel PCHP"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Resale Agreement between the Parties dated October 15, 2006 ("Agreement").

WHEREAS, AT&T and Excel PCHP entered into the Agreement on October 15, 2006, and;

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties hereby agree to Amend Section 19.1 of the General Terms and Conditions to delete customer information and replace it with the following:


