This correspondence is in response to the objections filed by Mike Dydo by e-mail May 14, 2009. As discussed below, neither of Mr. Dydo's "objections" has merit and should not delay the Commission's consideration of this Joint Application:

- Mr. Dydo objects that in absence of having possession of physical Certificates, 1. no valid transfer can take place. However, as you know, the Commission has ceased issuing actual Certificates to Water and Wastewater Utilities. See, for example, PSC Order No.: PSC-07-0717-FOF-WS.
- Mr. Dydo's complaint about the nonexistence of any emergency contact 2. number is premature. Pluris Wedgefield, LLC, will not take ownership of the utility systems until the transfer has been approved by the Commission and thus, would have no reason to have an emergency number at this time. This letter is to assure the Commission that upon the Commission's approval of this transfer and Pluris Wedgefield, LLC, taking over operations, that a twentyfour (24) hour, seven (7) days a week emergency number will be established.
