Additional Information

1. Please provide all available Discharge Monitoring Reports beginning from October 2008 to present.
2. Please provide a statement as to whether the pro forma additions in the last rate case were installed. These additions include the following:
 - (A) A computer system for \$1,455
 - (B) A DEP required 15,000 digester for \$18,881
 - (C) An improved and updated lift station at \$3,900
 - (D) An improved piping for percolation ponds at \$7,000
 - (E) Telephone alarms at lift station for \$400
 - (F) Chlorine Tank for \$200
 - (G) Chain fence at \$2,500
 - (H) Metal piping for \$700


