Hey Robin. Yak's certificate was cancelled in RAF Docket No. 080362-TI. The PAA imposing the \$500 fine was issued on August 11, 2008, and the company had 21 days to protest the Order. No protest was received, so the CO was issued on September 7, 2008, and their certificate cancelled effective the date the CO was issued. The 2007 fee and most of the late payment charges (all except \$7) was paid on November 4, long after everything had been finalized. I checked my old e-mails and couldn't find where anyone contacted me (either from Yak or TMI). Let me know if your records show something different.

The company will need to reapply and will first have to pay the 2008 RAF and the \$500 fine.

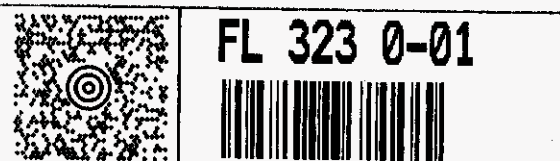
