RE: Cancellation of Certificates for Advanced Tel, Inc.

Dear Ms. Cole:

As you may recall, on September 30, 2008, Advanced Tel, Inc. d/b/a Eatel ("Eatel or Company") filed a letter with the Florida Public Service Commission requesting to cancel its certificates in the state of Florida effective December 1, 2008. At that time, Eatel indicated that it had five (5) customers in the state of Florida that would be affected by its request to discontinue service.

However, in conjunction with compiling tax information earlier this year, Eatel discovered that five (5) additional customers located in Florida had neither received Notice of the discontinuance of service, nor had they been disconnected from long distance service as planned by the Company. This error resulted from the fact that these customers' locations had been incorrectly geo-coded, and did not originally appear to be located in the affected service territory. Consequently, they were overlooked when the customers that were affected by the discontinuance of long distance service were identified and subsequently notified. For this reason, Eatel is submitting this letter in order to make the Commission aware of this situation.

Eatel has also taken corrective measures, and sent a Notice to these customers, to make them aware of the fact that their long distance service is going to be discontinued. A copy of this Notice that was sent to these customers is included as an attachment to this letter. The Notice sent to these customers is identical to the Notice that was previously sent to the other customers affected by this service change, except for the necessary date changes. The Notice states that these customers will be given seventy seven (77) days from the date of the Notice to locate a new service provider in their area. Eatel is also working directly with these customers to assist with this transition, and has contacted the Federal Communications Commissions to make them aware of this situation as well.

A copy of the Commission Order which authorized the cancellation of Eatel's Certificate and the associated discontinuance of service is attached to this letter as well. However, Eatel respectfully provides this additional information in order to make the Commission aware of this recent development.

Dear Mr. Bienvenu:

This letter is to inform you that on or about July 31, 2009, Advanced Tel, Inc. d/b/a EATEL will no longer be providing domestic or international long distance service within the state of Florida. We are providing this notice well in advance of our target termination date to provide you sufficient time to make the necessary arrangements with another carrier. It is our understanding that domestic and international long distance services are available to you from a number of other carriers. Generally, you will find a list of long distance service providers in your local telephone directory. In order to make your selection, you must contact your long distance service provider of choice and request that your service be switched to that provider.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the FCC releases the public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, referencing the §63.71, Application of Advanced Tel, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
