Dear Ms. Cole:

Pursuant to the requirements of Section D(1) of AT&T Florida's Extended and Modified Service Guarantee Program (SGP) approved by the Florida Public Service Commission, (See Order No. PSC-05-0440-PAA-TL in Docket No. 050095-TL, dated April 25, 2005), AT&T Florida hereby declares a service emergency due to excessive rain for the NPAs / NXXs contained in the attachment as of May 22, 2009. The areas included are Brevard, Volusia, Flagler, St Johns, Duval, Clay, and Nassau counties.

The rainy conditions have adversely affected the east coast of Florida, and in some cases caused historic flooding. We have experienced more than 20 inches of rain since Monday, May 18 and expect an additional 6 inches of rain today. The rain has resulted in numerous road closures around the state.

It will take some time for AT&T Florida to recover and regain normal installation and repair activities. AT&T Florida will provide to the Commission updates on our recovery efforts and advise when the service emergency period has concluded.
