All membership levels entitle individuals to utilize the various resort amenities and services, including the natural gas heated pool, hot tub, and restaurant.

Enclosed is a copy of a brochure of the Lake Como's membership rates and other services offered (e.g., motel rooms, cottage & travel trailers, tent sites, RV camp sites, etc.) – Exh. 1(a). Also enclosed is a copy of a map of the entire resort detailing the various resort amenities – Exh. 1(b).

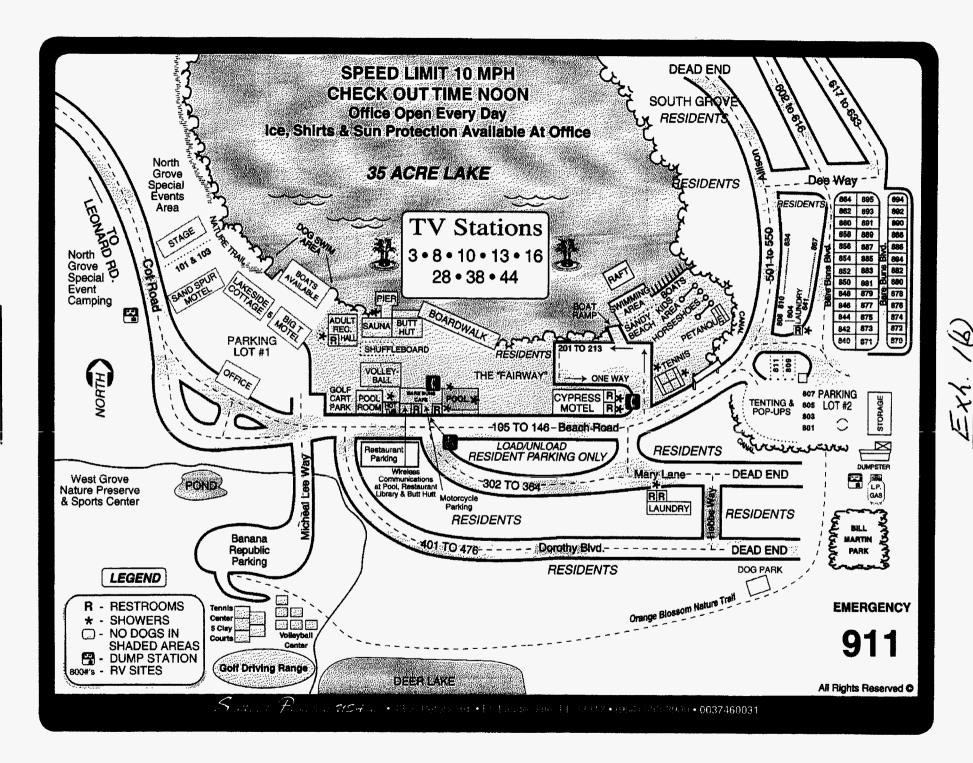

We are a non-profit corporation operating as a family nudist resort in Pasco County, Florida. Natural gas is used to heat our pool & hot tub, for cooking food in our restaurant/café', in our hotel laundry, and a coin operated laundry facility. The gas flows through a single meter serving these operations. In reviewing our billing history, we discovered that the rate classification on the bills from TECO Peoples Gas ("Peoples") was changed from Commercial GS-2 to Condominium RESA (CMD) around August of 2005 resulting in a higher distribution charge. After looking into this matter in more detail, we believe our rate was changed in error and, as such, we are requesting our rate be reclassified back to the lower commercial GS-2 rate. In addition, we should be retroactively refunded the difference in rates billed in error since August 2005.

Based on discussions with Peoples' representatives and others, we found that the rate change should have only been made to condominium associations, cooperative apartments, and homeowner's associations using gas in their common areas for residential purposes only. However, our facility is not a condo or homeowners association or a cooperative apartment. Furthermore, the gas is used in a number of different commercial operations - not residential. Any gas used for residential purposes is LP gas, which is purchased by individuals and delivered by different LP gas suppliers.

It appears someone at Peoples may have assumed we were a "cooperative" apartment simply because our name includes the term "Co-op." However, this is clearly not the case.

Even if we were a cooperative apartment or a condominium or homeowners association, natural gas use at our facility is commercial because we charge a variety of fees to utilize our facility. Specifically, we charge membership fees ranging from daily entrance fees up to a three-year membership (see enclosed). These fees allow patrons to utilize the resort's various facilities, including the gas heated pool, hot tub, and restaurant. Additional fees are charged to stay at the resort's hotel and campground. Separate fees are also charged at the restaurant for food items and the coin laundry. In fact, the gas commodity we purchase from our 3rd party gas supplier is subject to sales tax because its use does not qualify for the residential sales tax exemption.

As such, our rate classification should never have been changed from commercial to residential. Therefore, please see that our account is switched back to the commercial GS-2 rate immediately. In addition, please see that we are issued a retroactive refund for the difference in rates billed in error so that we are made whole.
