I attended the Public Service Hearing in Daytona Beach 6/23/09.

My husband & I have been in the construction business for 38 years. In 2006 we employed around 50 people, now only 15. The economy has hurt us so much since 2007 that we are just hanging on after cutting everything possible including all employee benefits! In addition, all employees including owners have taken a 10% cut in pay! We have had to cut our pricing to get work because there are so few jobs available to bid on.

I feel that it is incredulous and shameful that FPL would ask for a 30% increase when we are in this recession! Especially when FPL is making money! I looked FPL up on the internet & was amazed at how much money they have made year after year. FPL's 2009 1st quarter profit according to Market Watch was 364 million!

The unemployment rate in Volusia County is now 10%, how can the unemployed pay an increased Electric Bill? Or our elderly, who are on fixed incomes? What about my business? We have replaced windows and implimented many other energy saving items, but I cannot operate without computers, lights or air conditioning. I cannot lower my business electric usage further. What about my home? I have already reduced everything possible including setting the air conditioning at 80 degrees, which is not at all comfortable! Many of my employees have cut their home telephone service, cable TV, live & sleep without air conditioning, reduced driving except to & from work, and they do not eat out. Everyone I know is suffering greatly right now, except FPL.

Please do not grant FPL any increase at all. I absolutely cannot pay more for electricity or any other service!

Thank you for giving me the opportunity to voice my opinion and for having all the public hearings!
