Pursuant to Section 367.081 (4) (a) and/or (b), Florida Statutes, water and wastewater utilities are permitted to pass through, without a public hearing, a change in rates resulting from: an increase or decrease in rates charged for utility services received from a governmental agency or another regulated utility and which services were redistributed by the utility to its customers; an increase or decrease in the rates that it charged for electric power, the amount of ad valorem taxes assessed against its used and useful property, the fees charged by the Department of Environmental protection in connection with the National Pollutant Discharge Elimination System Program, or the regulatory assessment fees imposed upon it by the commission; and costs incurred for water quality or wastewater quality testing required by the Department of Environmental Protection.

On May 12, 2009, Plantation Bay Utility Company filed its notice of intention with the Florida Public Service Commission to increase water and wastewater rates in Volusia/Flagler County pursuant to the above Statutes. The filing is subject to review by the Commission Staff for accuracy and completeness. Water rates will increase by approximately 2.40% and Wastewater rates by 1.77%. These rates should be reflected on your bill for services rendered on or after July 11, 2009.

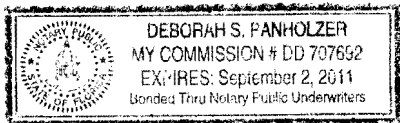
