Notice for Immediate Attention:

We have a **pending notification for abandonment** on the file regarding this utility.

Our notice was filed and received by the commission on May 6th, 2009 for a 75-day notice provided. This should put a time for action somewhere close to the 20th of July, 2009, if our math is correct.

We are presently in negotiations with Marion County and have a public hearing scheduled for Tuesday, July 21, 2009. The outcome of this hearing may dramatically affect the survivability of the utility company. Loch Harbour Utilities formally request at this time to cause a 30-day delay in any action being taken with regards to the abandonment of this utility until August 20, 2009, pending further notice of the findings of the settlement with Marion County commission.
