FLORIDA POWER & LIGHT COMPANY'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

Pursuant to section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL"), hereby requests confidential classification of FPL's Responses to the South Florida Hospital and Healthcare Association's ("SFHHA's") Tenth Request for Production of Documents, No. 102, in Docket No. 080677-EI, and in support states:

- 1. On May 19, 2009, SFHHA served its Tenth Request for Production of Documents on FPL. FPL's responses to SFHHA's Tenth Request for Production of Documents, No. 102, contains information of a confidential nature. On June 18, 2009, FPL provided responses to SFHHA's Tenth Request for Production of Documents for review in FPL's Tallahassee office. Staff has requested copies of FPL's Responses to SFHHA's Tenth Request for Production of Documents, No. 102. Pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, FPL is filing this Request for Confidential Classification.
 - 2. The following exhibits are included with, and made a part of, this request:
- a. Exhibit A consists of a compact disc which includes a copy of the confidential material on which all information that FPL asserts is entitled to confidential treatment has been highlighted.

- b. A copy of the confidential pages of FPL's responses to SFHHA's Tenth Request for Production of Documents, No. 102, with redacted information that FPL asserts is entitled to confidential treatment is not provided, as the information is in spreadsheet format in electronic version on compact disc, and FPL would not be able to redact such information in such format without impacting other information in the files.
- c. Exhibit C is a table containing an identification of the information highlighted in Exhibit A, together with references to the specific statutory bases for the claim of confidentiality and to the affidavit in support of the requested classification.
- d. Exhibit D includes a copy of the affidavit of Kenneth Getchell, Manager of Customer Service, Cost and Performance, in support of this request. An original will be supplied by close of business on July 22, 2009.
- 4. FPL submits that the highlighted information in Exhibit A is proprietary confidential business information within the meaning of Section 366.093(3), Florida Statutes. This information is intended to be and is treated by FPL as private, and its confidentiality has been maintained. Pursuant to Section 366.093, such information is entitled to confidential treatment and is exempt from the disclosure provisions of the public records law. Thus, once the Commission determined that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the hard of disclosure against the public interest in access to the information.
- 5. As the affidavits included in Exhibit D indicate, the information provided by FPL contains information related to competitive interests, the public disclosure of which would impair the competitive business of FPL. Section 366.093(3)(e), F.S. The information concerns

and Advanced Metering Infrastructure study containing competitive pricing, performance, contractual, and model information.

6. Upon a finding by the Commission that the information highlighted in Exhibit A, and referenced in Exhibit C, is proprietary confidential business information, the information should not be declassified for a period of at least eighteen (18) months and should be returned to FPL as soon as the information is no longer necessary for the Commission to conduct its business. See S.366.093(4), F.S.

WHEREFORE, FPL respectfully requests confidential classification of the material described herein.
