PROGRESS ENERGY FLORIDA, INC.'S SECOND SUPPLEMENT TO PREHEARING STATEMENT

Progress Energy Florida, Inc. (PEF), pursuant to Order No. PSC-08-0816-PCO-EI as revised, filed its Prehearing Statement in the above consolidated dockets on July 27, 2009. In an August 3, 2009 email from Staff Senior Attorney, Katherine Fleming, parties were requested to provide cumulative values in a narrative response to Issues 8 and 9. Subsequent to that email, a revised Issues List was distributed to the parties renumbering Issues 8 and 9 to Issues 9 and 10 respectively. Accordingly, PEF hereby supplements its Prehearing Statement incorporating the re-numbered issues with the following information:

<u>ISSUE 9</u>: What residential summer and winter megawatt (MW) and annual Gigawatt-hour (GWh) goals should be established for the period 2010-2019?

<u>PEF Position:</u> PEF's annual goals are listed in the table below. The cumulative effect of these goals through 2019 would be a summer MW reduction of 323 MW, a winter reduction of 463 MW, and cumulative energy savings of 488 GWh. (Masiello)
