According to our records, MSKP Town and Country Utility, LLC, d/b/a Town & Country Utility (Town & Country), has not paid regulatory assessment fees (RAFs), as required by Rule 25-30.120, Florida Administrative Code, for the year 2007. Pursuant to Rule 25-30.120(2), F.A.C., regulatory assessment fees must be paid by March 31 of each year. Administrative penalties, plus interest, may be imposed as provided for under Rule 25-30.120(7), F.A.C.

Staff's calculation of the appropriate RAFs, plus the appropriate penalty and interest through August 30, 2009, is set out below.

Pursuant to Rule 25-30.120(7)(a)2., F.A.C., Town & Country continues to be responsible for paying interest of one percent every thirty days on the unpaid balance of the regulatory assessment fees. The amounts shown above have been calculated as of August 30, 2009.

The interest amount changes after August 30, 2009, and increases over time. Any delay in payment past August 30, 2009, will subject Town & Country to additional interest. In addition, if payment in the above listed amount is not received by the stated due dates, the Commission may initiate show cause proceedings. If show cause proceedings are initiated, and the utility is found to be in violation of Commission rules, pursuant to Section 367.161, Florida Statutes, the Commission is authorized to impose fines of up to \$5,000 for each day the violation continues.
