

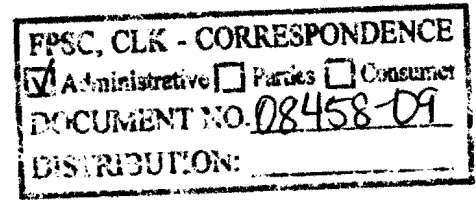

### Case Background

Utilities, Inc. (UI or parent) is an Illinois corporation which owns approximately 75 subsidiaries throughout 15 states including 15 water and wastewater utilities within the State of Florida. Cypress Lakes Utilities, Inc. (Cypress Lakes or Utility) is a Class B utility providing water and wastewater service to approximately 1,426 residential and 44 general service customers in Polk County. Rates were last established for Cypress Lakes in its 2006 rate proceeding.<sup>1</sup>

On June 30, 2009, Cypress Lakes filed its application for a limited proceeding pursuant to Section 367.0822, Florida Statutes (F.S.). Unlike a full rate case, Cypress Lakes' request consists

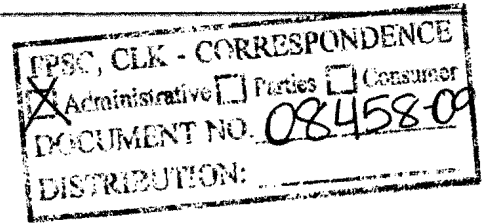

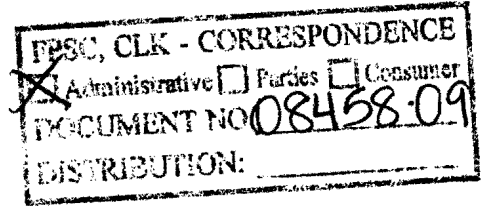

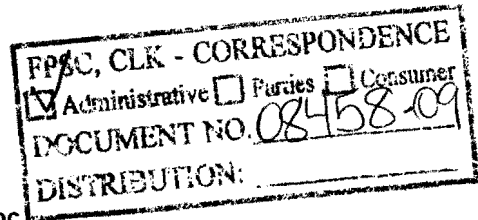
